A payment facilitator is a merchant services provider that merges the payments function with software capabilities, often focused on one or a few vertical markets. Payment facilitators have emerged to become one of those technology capabilities that has challenged the balance of power in the merchant services space.

**Often referred to as a Merchant of Record, Aggregator, PSP, ProFac*

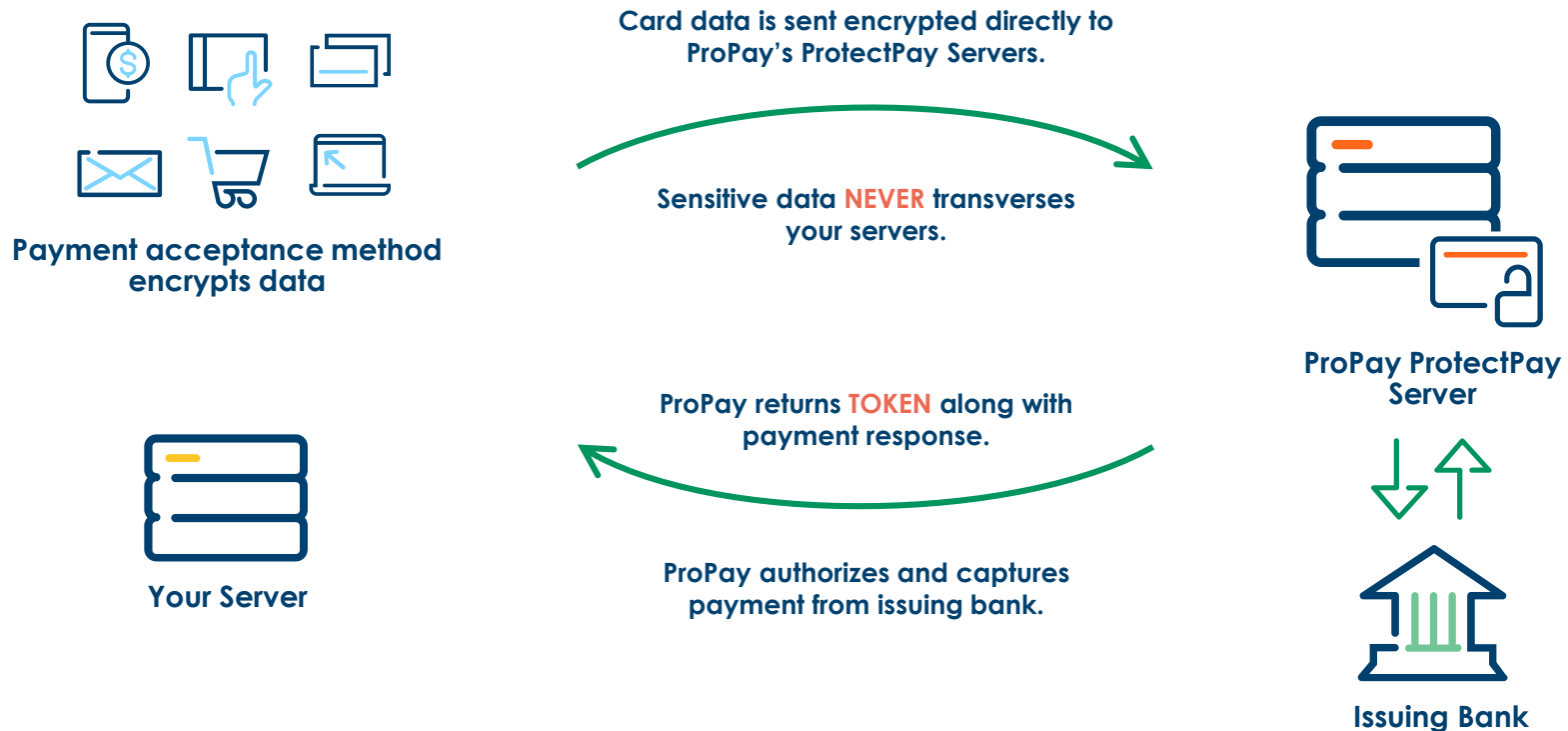

Point-to-Point Tokenization - PCI Level 1

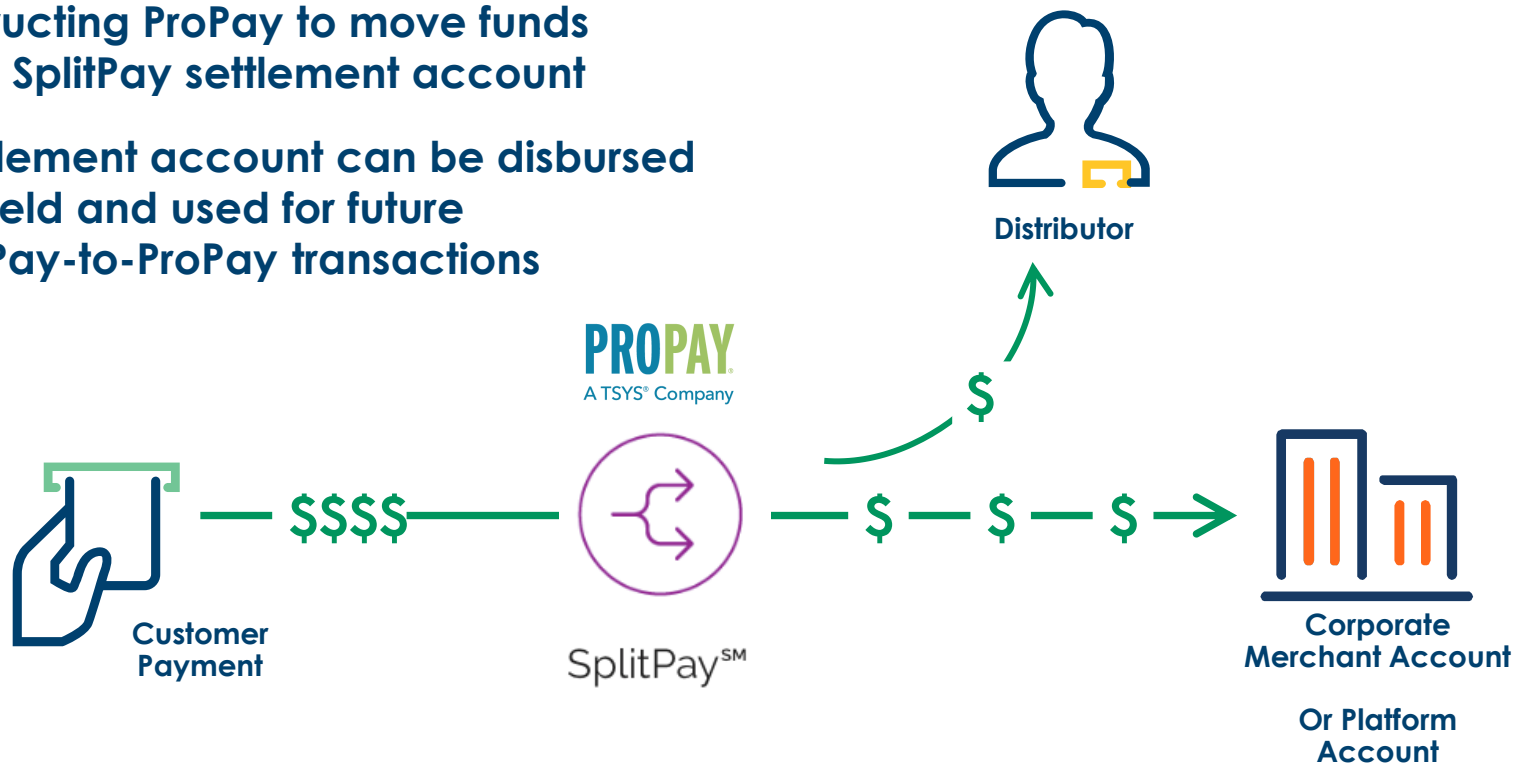
- Storage of customer data

Allows for the collection of convenience and service fees at the time of transaction

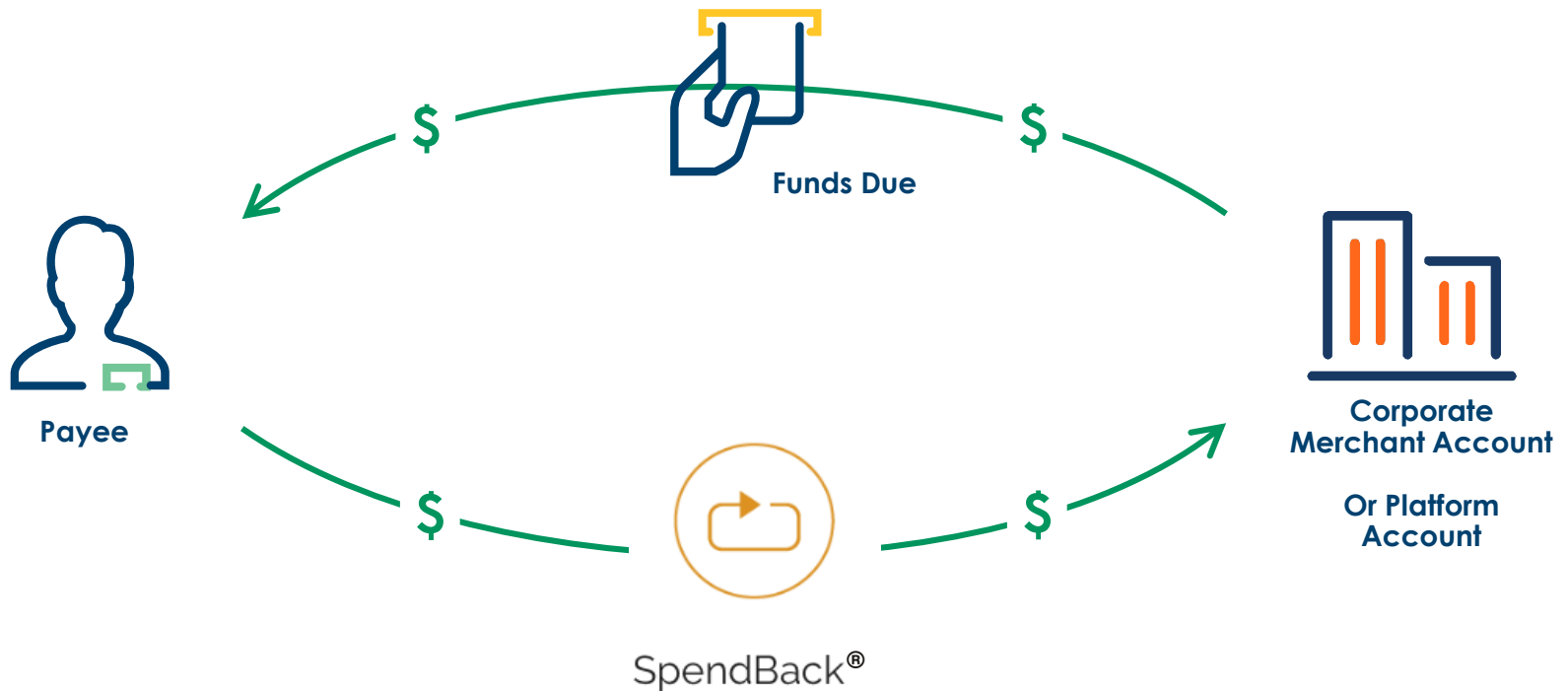
- Single transaction split multiple ways (Credit/Debit or ACH)
- Partner submits a 2nd (or more) transaction(s) instructing ProPay to move funds to a SplitPay settlement account
- Settlement account can be disbursed or held and used for future ProPay-to-ProPay transactions

FUNDING CAPABILITIES

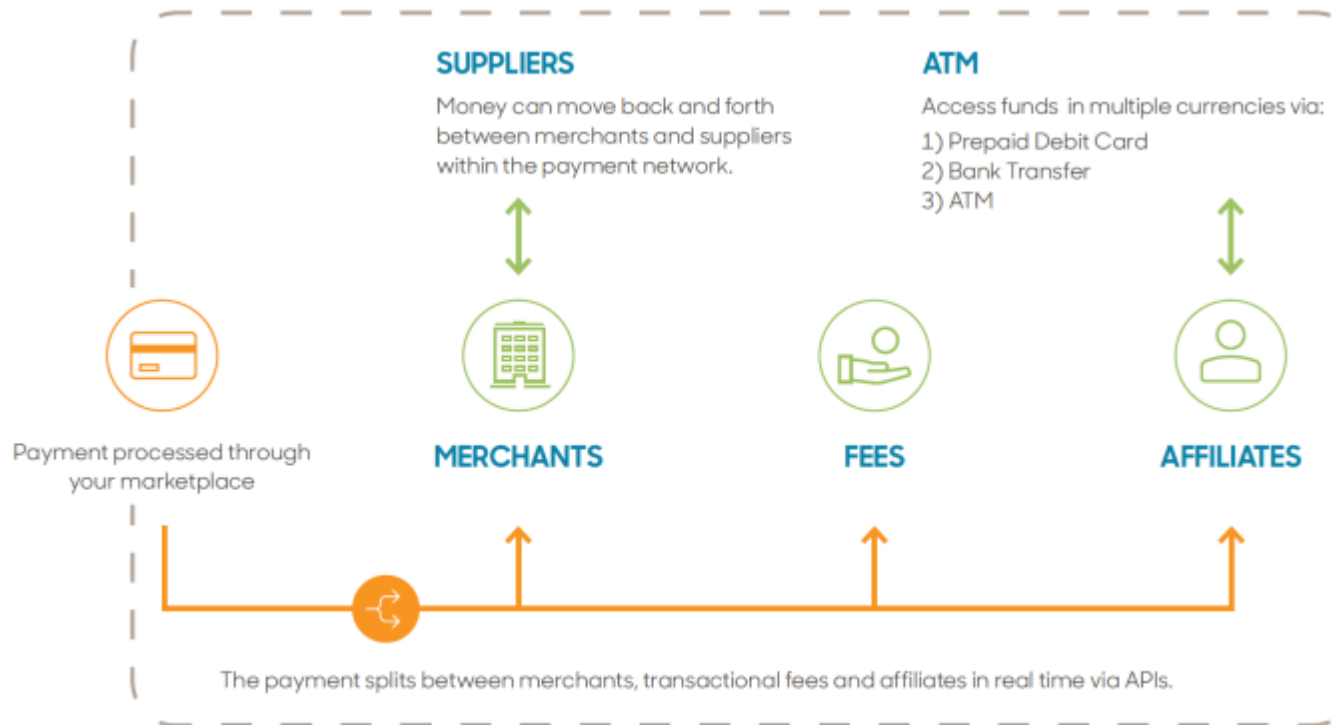
- **Sub-Merchants are funded via API instructions**
 - or, through predetermined mechanisms within the system (no overhead for you)
- **Standard process is net settlement**
- **ProPay supports gross dependent upon pricing and business model**
- **Reserves or disablement of settlement can be used to mitigate risk**
 - Example — hold majority of funds until the non-profit 5k event is held
 - We'll work with you to meet the needs of your customer base.
- **Flash Funds allows for instant deposit to merchants bank account (No waiting for an overnight deposit through ACH)**

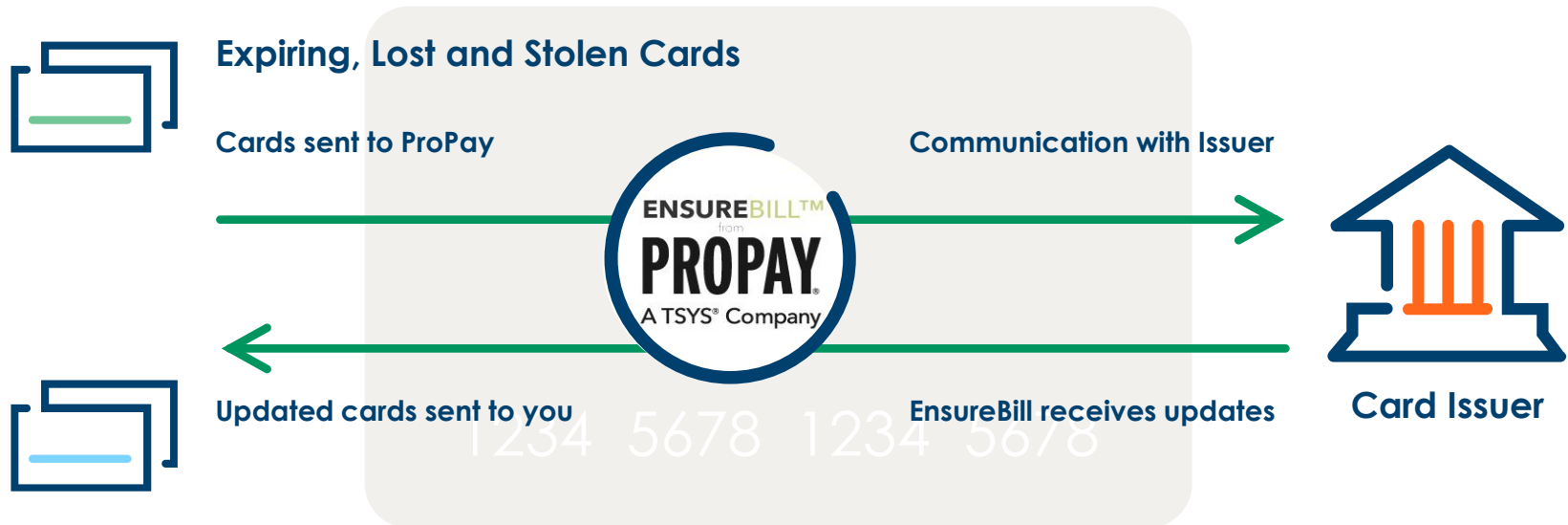

- Minimal development
- User leaves partner site to co-branded page.
- “Web Hooks” can communicate new account details to partner.
- Subject to Limits: Additional fields made mandatory based on partners' expected risk profile and desired processing volume.

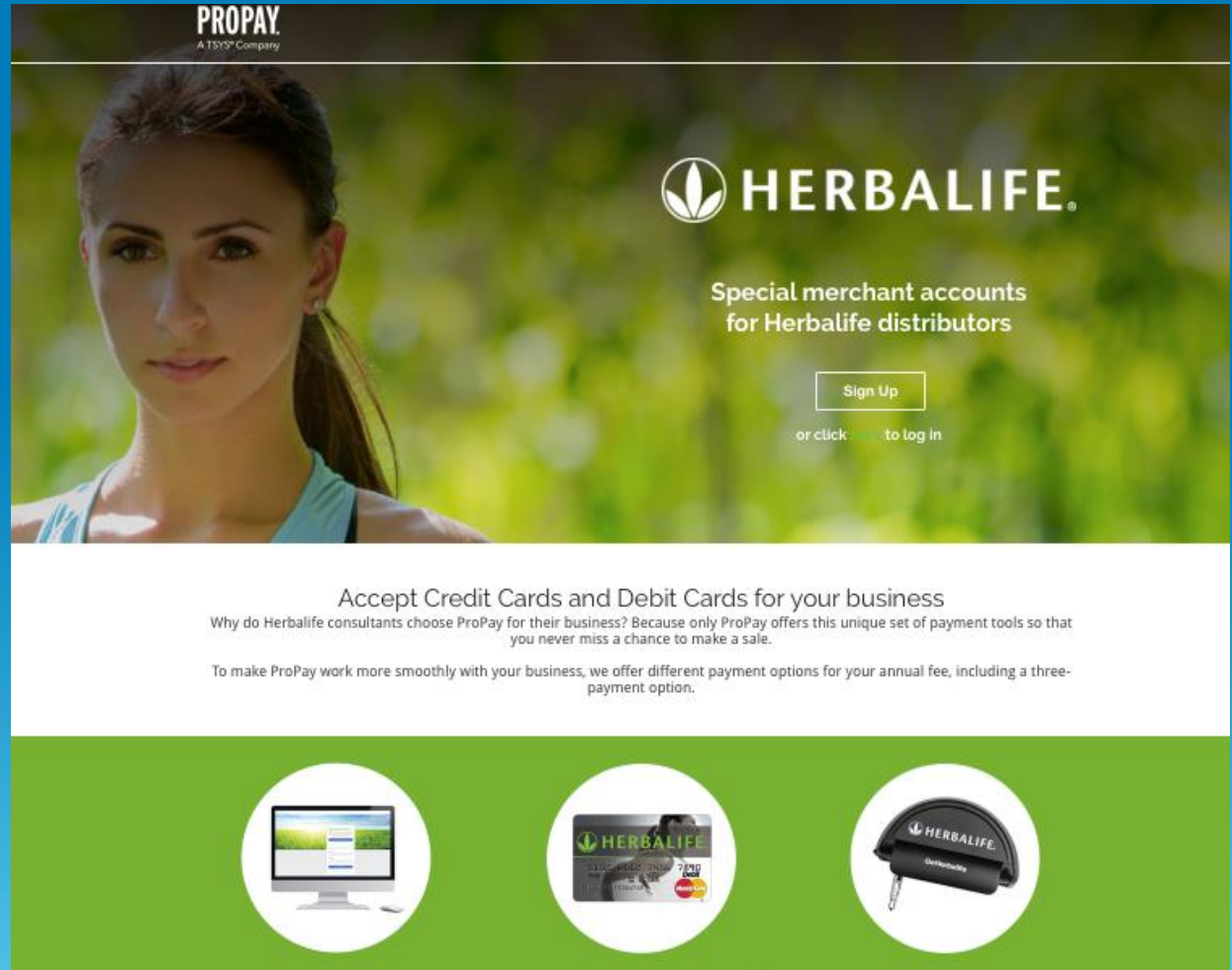

- All support and service provided by ProFac to sub-merchant
- Funding schedule to be determined by ProFac
 - System supports funding to the ProFac or submerchant
